## 5. Treasurer's Report (Melinda M.):

### 8. Structure and Bylaws (Pat B.):

Pat talked about the joys of answering secretary emails and sharing experience with the AZ Area S&B Chair, mentioned that he has updates for items in old business.

## 9. Convention Chair (Chris G.):

Figuring out the details of the program, chair of panels committee has begun inviting speakers. Registrations continue to come in from all over. All speakers are settled except for main Saturday, but there is a likely candidate. No movement with money but we are in a good place. Making outreach efforts. Most important thing is that the hotel has told us that starting June 30<sup>th</sup> the event restrictions will be lifted.

# 10. Haws Conference Liaison (Dalton L. in Ole's absence):

Not a whole lot going on, struggling to fine good time for committee to meet. Chris G. mentioned that a lot of questions come to the convention channels about the conference, suggested updating conference website and improving communications. Question about when new business will be dispersed to the board.

# 11. Old Business:

- Pat B. will draft language for how liaisons will attend these meetings, as far as at the start of the meeting or throughout the entirety of the meeting. Ole makes a motion to accept these edits and additions to the bylaws, seconded. Pat makes a motion to table this, seconded, passes.
- Motion to close our Arizona Federal Credit Union checking and saving accounts, seconded, motion passes. updated 4/11/21: stays on old business until debit card and other issues are sorted

- Melinda M. makes a motion to remove Josh Quinn and Faith Mullender (Brewster) from all bank accounts, seconded, motion passes. updated 4/11/21: stays on old business until debit card and other issues are sorted.
- Pat makes a motion to create a second jobs duties and descriptions for the board, seconded, passes.
- Motion to add item B under article VI "HAWS Officer Handbook" and accept handbook is made by Pat and passes.
- Pat makes a motion to make the convention chairperson a voting member of the board, seconded. Motion is amended to read: Starting after the 2021 HAWS Convention, the Convention Liaison position will always be maintained by a voting board member and the duties of this job will be updated to reflect the importance of communication and decision making inherent to this position. Motion passes.
- Billy N makes motion to look into the feasibility of trademarking the name "Heroin Anonymous"

\*Seconded and passes

Updated 5/2/21- got into discussion about 12 step copywrites with a paralegal involved with small trademark/ copywrite firm. Billy is sitting down with paralegal this month to go over recommendations.

#### 12. New Business:

- Vance S. discussion and vote- board was split, consensus was that we want to speak to references. Pat will ask Vance for more time to deliberate and discuss with Billy a way to look into references. Tabled until next month.

- Motion that Treasurer reach out to PayPal the week of August 2<sup>nd</sup> to address the \$259.87 charge on our old bank account from a PayPal portal, motion passes.
- Melinda asks that the minutes be updated to reflect information requested by PayPal for account changes.
